

PROGRAM CHANGES

COMPUTER ENGINEERING UNDERGRADUATE PROGRAM CHANGE

<u>Justification</u>: Major requirements change to upper division g): The CEN Committee felt that one four-unit course that covers the basics of Analog and Digital Signal Processing is an appropriate requirement for CEN majors. EE 110A and EE110B cover Analog and Digital processing, respectively, but the CEN committee felt that 8 units of signal processing was too much to require for CEN majors. The ECE Department created the EE 111 course in response to the CEN Committee's desire for a 4-unit signal processing course that could meet its requirements for CEN majors.

Removal of EE 110A/B from technical electives: EE 110A and EE 110B cover Analog and Digital Signal Processing respectively. The new required EE 111 course covers the aspects of these topics that are appropriate for CEN majors. Allowing CEN majors to take EE 110A and/or EE 110B as electives would allow students to earn credit for a significant amount of redundant course material. For these reasons, these courses should be removed from the list of CEN technical electives.

Adding EE 165 to technical electives: EE 165 is a new course created by the ECE department that covers design for reliability for integrated circuits and systems. This topic is well within the scope of Computer Engineering, and therefore EE 165 is appropriate technical elective course for CEN majors.

Language regarding the undergraduate faculty advisor: The original language was appropriate for an earlier time when the CEN major was jointly administered by the CS and ECE (then EE) departments. CEN is now a standalone Program with its own chair and its own undergraduate faculty advisor. The CEN committee voted to change the language so that the CEN chair and undergraduate faculty advisor to perform these functions, not the respective CS and ECE chairs and faculty advisors.

COMPUTER SCIENCE UNDERGRADUATE PROGRAM CHANGE

JUSTIFICATION: The faculty examined and conducted a regular analysis of our requirements. In doing so, we came to the conclusion that the courses in the (g) category (select two of four courses, which were math and logic courses) no longer deemed "required" status, given the direction the field of computer science has taken over the past decade and the direction that the field is heading. Thus, we moved two of (g)'s four courses into the list of allowable technical electives; the third was already listed there, and the fourth was lower-division so not allowable as a technical elective (and not really appropriate as a technical elective anyways). We decided the number of technical elective units (28) was still appropriate to properly train and expose students, and thus if students might need additional units to graduate, they could choose from any of the excellent courses offered across campus (or choose additional courses from the technical elective list if they wish). However, with the additional courses in the technical elective list, we decided to require that at least half the technique elective units come from CS courses, because while the math and logic courses that already existed and that were recently added are all excellent and appropriate for technical elective credit for a CS major, we also want to ensure every student has an appropriate exposure to upper-division CS-focused coursework.

PROGRAM CHANGES

BUSINESS INFORMATICS UNDERGRADUATE PROGRAM CHANGE & CHANGE OF NAME OF MAJOR

JUSTIFICATION:

The CSE faculty voted to change the program name of Business Informatics to better reflect the overall content and direction of the major as it relates to both Business and Computer Science within BCOE. (Approved by the faculty of the Department of Computer Science and Engineering on March 9, 2016.)

The Computer Science and Engineering faculty re-examined the upper division requirements and felt that reducing the business elective units was appropriate, still having students take a substantial number of business courses, but also providing a good balance between CS and Business courses.

CHEMICAL & ENVIRONMENTAL ENGINEERING UNDERGRADUATE PROGRAM CHANGE

Justification:

- 1. Electrochemical Engineering (CHE 131) is a four unit course with content relevant to many chemical engineering industries, complements other listed technical electives (e.g., CHE 102, CEE 135, and CEE 132), complements the core curriculum (e.g., CHE 100, 122, and 130), and provides student with fundamental knowledge in engineering of electrochemical processes.
- 2. Analytical Methods (CEE 125) is a four unit course that is currently listed as a required course for the Chemical Engineering option. The content is relevant to the Chemical Engineering option, but should not be mandatory for all students in the option as it limits students in the selection of other technical elective options.
- 3. To meet the minimum of 18 units for the option the number of units from technical electives must be sixteen (16) with an additional two (2) units from the required CEE 010 course.




IT'S THAT TIME....TIMETO...

☐ If no additional nominations are forthcoming, a motion is called for to instruct the Secretary to cast a single ballot for the nominee, thus concluding the election.


