Action Items

1. Undergraduate Research Scholar Proposal

- As previously discussed at past Executive Committee meetings, the campus has proposed a research scholar program that would recognize/award an undergraduate student who completes all the requirements with distinction of "Undergraduate Research Scholar" which would appear in the awards section if the official transcript.

The CNAS Executive Committee has responded to the proposal by providing suggested changes to the "Basic Requirements" section in the original document. The stringent changes presented by the CNAS Executive Committee seem reasonable to the BCOE Executive Committee, however, they would like clarification regarding the suggestion to the requirement "Complete <u>3 quarters and 10 units (or equivalent)</u> of substantial research or original performance or creative work with a faculty member." What does equivalent mean? Can equivalent be removed? The Chair of the CNAS Executive Committee will be contacted for clarification.

2. Memorandum of Understanding for a Coordinated B.S./B.A. Degree Program Between Concordia University and UCR

As mentioned at a previous Executive Committee meeting, Concordia University is interested in creating a coordinated degree program with BCOE for transfer students. Concordia University sent Ravi a draft memorandum of understanding. One change Ravi made to the proposal was that instead of calling it a "joint B.S./B.A Degree Program Between Concordia University and UCR" it be called "coordinated B.S./B.A. Degree Program Between Concordia University and UCR." The Executive Committee endorses the program and language used in the draft. Once the MOU is in a final version, it will be presented to the Executive Committee.

3. Courses

The following courses were approved and forwarded to the Committee on Courses for review:

Gerardo Beni and Paulo Chagas attended the meeting to answer questions and provide clarification for the Executive Committee members regarding EE 156. This course is cross-listed with MUS 156. The Executive Committee is concerned that since this is an upper-division course, and there is not a prerequisite course, it might not be as technical as other upper-division Electrical Engineering courses and is worried that music students that enroll in the course might struggle. The Executive Committee feels that the value of this course is high, but suggests that Gerardo and Paulo possibly reconstruct the course so that it is introduced as a lower-division or project course that could be used as prerequisite course for an upper-division course to be proposed in the future. Paulo and Gerardo will reconstruct the course over the summer, and will present a revised course for the Executive Committee's review in the fall.
